



## **2. Purpose of the MoU**

The purpose of this MoU is to serve the society by:

1. Organizing Health Camps
2. Taking the patients to the hospital for treatment
3. Medical awareness and health education programs
4. Psychological counseling sessions and mental health support

The Parties agree to work together to promote awareness regarding health and serve the society.

## **3. Roles and Responsibilities**

### **3.1 Responsibilities of the First Party**

- Conduct various general OPD's viz., Medicine Pediatrics, ENT, Urology etc.
- Provide Medical Practitioners and support staff for smooth conduct of OPD
- Organize regular health camps
- Be open to expand its services

### **3.2 Responsibilities of the Second Party**

- Provide infrastructural facilities for OPD, health camps and Pharmacy
- Provide general equipment for conducting OPD and health camps
- Provide Medical machinery viz., X-Ray, Ultrasound etc. for general diagnosis
- Provide conveyance to medical and support staff to and fro
- Be open to expand its services

## **4. Funding and Resource Allocation**

- Each Party shall bear its own costs unless otherwise agreed in writing for a specific purpose.
- Each party will be free to take donations for this noble cause.
- Use of facilities and equipment shall be mutually decided based on availability and requirements.

## **5. Coordination and Communication**

- The First Party shall designate an authorized contact number for emergency communication. Likewise, the Second Party will assign an emergency contact number or designated coordinator to ensure seamless coordination.

## **6. Non-Liability Clause**

- While the First Party agrees to provide OPD services, it shall not be held liable for delays due to unavoidable circumstances beyond its control or for medical outcomes arising from the nature or severity of the emergency.

## **7. Confidentiality**

- Both Parties agree to maintain the confidentiality of proprietary information, research data, patient information and other sensitive materials.
- Confidential information shall not be disclosed to third parties without prior written consent.

## 8. Validity and Duration

- This MoU shall remain valid for three (3) years from the date of signing unless terminated earlier.
- It may be extended through written consent by both Parties.

## 9. Amendment and Termination

- Any amendment to this MoU must be made in writing and signed by both Parties.
- Either Party may terminate the MoU by giving 30 days' prior written notice.
- Activities in progress shall be completed or mutually resolved upon termination.

## 10. No Legal or Financial Obligation

This MoU is an expression of mutual intent and does not create any legal, financial or contractual commitments unless specified in subsequent agreements.

## 11. Dispute Resolution

In case of any dispute arising from this MoU, the Parties agree to resolve it amicably through discussion. If unresolved, the matter may be referred to arbitration in accordance with applicable laws.

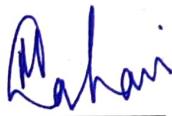

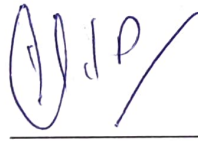
