Memorandum of Understanding

This Memorandum of Understanding (MoU) for the Value Education program of Vrindavan Chandrodya Mandir, Vrindavan at K D University, Mathura has been executed on 18th day of March, 2026 at Mathura between

K D University an educational institution located at Mathura, Uttar Pradesh, represented by its Vice-Chancellor, Dr Manesh Lahori, hereinafter called as K D Univ.

AND

Value Education Program, conducted by Vrindavan Chandrodya Mandir, Vrindavan, Mathura District, Uttar Pradesh - 281121 represented by its Vice President His Grace Akrura Krishna Dasa, hereinafter called as VEP, and the expression of which shall include its representative Aniruddha Balam Das, administrator.

In order to ensure the smooth implementation of the program, the following roles and responsibilities have been mutually agreed between K D Univ. and VEP.

Vale Education Program (VEP) will:

1. Prepare and present the necessary curriculum, teaching techniques, notes and other such materials (digital and audio visual) and methodologies as may be required to effectively conduct the program.
2. Finalize the schedule and curriculum of the courses in consultation with the authorities of the associate University and will include mutually acceptable suggestions from K D Univ. into the curriculum.

7. Serve a prior notice to K D Univ. in case there is a substantive change (from VEP's side) in the content of the curriculum or any of the previously agreed upon details.


K D University will:
